

YOUTH MASTERCARD BACKPACK GIVEAWAY

RULES AND REGULATIONS

Eligibility

- ▲ This contest is open to any resident of Canada, excluding the Province of Quebec, who is at least 19 years of age on the date that he or she enters the contest.
- ▲ This contest is open to any member between the ages of 19 and 24 who apply and are approved for a SASCU Mastercard
- Only individuals are eligible to win. Groups, organizations or other non-natural persons are not eligible to enter or to win.
- ▲ SASCU employees and directors, and their immediate family members (immediate family members are defined as family members (and any other adult) who live in the same household) are not eligible to enter or win.

How to Enter

- ▲ Contest starts: August 23, 2022 at 12:00 p.m. PT
- ▲ Contest ends: September 30, 2022 at 5:00 p.m. PT
- ▲ Draw date: October 3, 2022. Winner will be contacted by phone and/or email.
- ▲ No purchase necessary to enter this contest.
- ▲ Apply for a SASCU Mastercard
- ▲ Limited to one entry and prize per individual.
- ▲ One entry will be drawn from each of five (5) SASCU ballot boxes.
- ▲ In order to claim a prize, the prospective winner must correctly answer a mathematical skill-testing question provided by SASCU staff member presenting the prize.

Prizes

- ▲ Five prizes will be awarded of equal value consisting of:
 - One (1) backpack

Determination of Winner

- A Winning entries will be determined by a random draw scheduled for October 3, 2022 or as soon as practicable thereafter.
- A The first entrant of each draw whose eligible entry is drawn and who correctly answered the skill-testing question, and who otherwise complies with these rules, will be named the winner.
- The winners agree to release and hold harmless SASCU and each of its agents, employees, directors, successors and assigns against any and all liability in any way associated with the Contest and sign a Release of Liability waiver form.

SASCU

- ▲ The winners must, by October 7, 2022, have claimed their prize. If a winner does not claim their prize by this date, such prize is forfeited.

- ▲ The Contest and the Rules is subject to all applicable municipal and provincial laws in British Columbia and federal laws in Canada.

Before being declared a winner, selected entrants will be required to sign a Release and Waiver form:
